

IMPORTANT: You should familiarise yourself with the Business School's **Guide to Citing, Referencing and Avoiding Plagiarism** before consulting this shorter A to Z list of example references.

The APA (6th ed.) style is a version of the Harvard method of referencing. Short citations (usually identifying the author and date of your source) appear in the text of your work. These direct the reader to full references in a list at the end. You need to include a citation every time you quote, paraphrase, summarise, or otherwise draw upon the work or ideas of another person. Careful referencing will allow your reader to distinguish between your own ideas and those of others, and to identify and check the sources used in your work. It will also help you to avoid any accusations of plagiarism. Always include page number(s) in citations to identify the exact location of the text you are referring to, unless you are drawing attention to the whole book, article, etc. For online sources, include the DOI if there is one; if not, use the URL (and a retrieval date for any source likely to change over time).
